- 2.2 2019 Audited Financial Statements Chad Lauzon
 - The draft audited financial statements were presented to the Foundation Committee members
 - Auditor's report is on the first page; qualified opinions are on the first paragraph followed by management and board's responsibilities and then the auditor's responsibilities; auditor gives qualified opinions because cash donations cannot be verified
 - Some donations are restricted for specific hospitals or use such as the SCM Redevelopment (AGH)
 - Donations and fundraising: General fund \$2,500; BMH \$0; AGH \$188,558; LMH \$2,400; 2019 Total \$193,458; 2018 Total \$384,038; the audit for the Foundation is done pro bono
 - Expenses: audit fees \$2,500; bank charges \$157; Advertising \$953; Prizes and

events \$13,279; Licence fees \$150; Supplies \$8,448; Total \$22,987; 2019 Total \$25,487

- Surplus for the year \$167,971
- Fund balances, beginning of year: General Fund \$5,401 / BMH \$5,798 / AGH \$352,615 / LMH \$22,428 / 2019 Total \$386,242
- Fund Balances, end of year: General Fund \$5,401 / BMH \$5,798 / AGH \$518,186 / LMH \$24,828 / 2019 Total \$554,213
- Current assets: General Fund \$17,308 / BMH \$150 / AGH \$514,561 / LMH \$20,358 / 2019 Total \$552,377
- Liabilities = money from the general fund (\$11,907) is due to the other funds; this money has not been transferred yet
- Fund balances: externally restricted \$517,068; unrestricted \$37,145
- Cash position, end of year: \$552,377
- There are specific rules for charities; the CRA does not allow foundations to accumulate funds; 3.5% of funds must be disbursed every year; as the AGH Foundation is accumulating funds for future use, we would have to ask the CRA's permission to accumulate cash or disburse funds to AGH to reimburse them for their start-up costs for the SCM redevelopment
- This would require the Foundation Board's approval
- Disbursement quote of 3.5% is \$14,248 over two years ending March 31st, 2019. For 2020, it will be around \$16,000.
- A motion to approve will be required once the disbursement amount is determined. A list of expenses incurred will be distributed to foundation members.
