 - One of the committee's goals is to hire a physician recruiter for the communities of Cochrane, Iroquois Falls and Matheson. Many communities in Ontario have an active volunteer committee such as the Worker Bees and a full-time paid physician recruiter, which has proven to be very successful in physician recruitment. Examples of communities include Marathon, Hearst and Kapuskasing.

It was decided that both positions need to be kept separate as their job descriptions are too demanding and very different in nature for a combined position.
