- 4.1 Foundation Coordinator Position Update P. Chatelain

4.2 <u>Income Statement Review</u> – P. Chatelain

- The expense reports for the period of April 1, 2021 to November 8, 2021 were provided for information
- The expenses by supplier summary was provided for the period of April 1 to November 8, 2021
- The SCM Redevelopment costs capitalized on AGH were provided for information
- Anson General Hospital's expenses totalled \$572,615

4.3 Marketing Update – J. Cybolsky

• Jesse provided the following statement via email: "I am confident we will get over the \$10,000 sales mark before Friday morning but we are not there yet and right now, are around where we were about this time last month. So there has not been much improvement yet."

- Next steps are submitting a revised financial package; we were advised to use the 2015 design manual; the architect is working on the new 96-bed plans
- The construction of many LTC homes under redevelopment has been put on hold because of the increased construction costs

4.6 <u>SCM Fundraising Events</u> – S. de Laplante / G. Forget

- We are looking at another curling bonspiel; considering an auction table; have to review the meal menu as the food has to be cooked in-house
- Selling tickets for another \$10,000 draw around Easter

5.1 Advertising Discussion – Chair

- As of November 17th, the 50/50 draw has generated \$95,705.87; winners received \$51,000; expenses totalled \$22,932.87
- The total profit for this period is \$44,705
- It was recommended that we advertise these numbers on our Facebook page and in the local newspapers of Cochrane and Iroquois Falls in order to generate more sales
- Once the coordinator is hired, will look into signage and pamphlets
- The Moose Radiothon is being held December 3, 2021; the money raised will go towards

an anesthetic gas machine for the OR at Lady Minto Hospital
