- 4.1 <u>Income Statement Review</u> P. Chatelain

4.2 <u>Monthly Report/Marketing Update</u>– K. Browne

- To date, \$120,405.00 has been given out in grand prize jackpots, \$12,000.00 in early bird cash prizes and 5 additional early bird prizes.
- MTO was contacted in regards to billboard advertisement on HWY 101. They are currently doing an inventory of signs. The Foundation has been placed on a waiting list. When an opening become available the cost of \$750.00 for a five-year term (plus the cost of the billboard itself).
